6. President's report

The President spoke to the following report:

Red Hill Regenerators (RHR) has worked with energy on a number of fronts this year.

Highlights

- The monthly Sunday activities have been dominated by the work removing Cootamundra wattle on the northern slopes of Red Hill (above Mugga Way). The area up to the fence was cleared, including the hazard-reduction burn area close to the summit road. Other activities included the removal of woody weeds, thistles and verbascum as well as the annual count of the Button Wrinklewort.
- A book, *Moments from Red Hill*, has just been published. It celebrates the flora and fauna on the Reserve, through poetry, line drawings and more. Michael Mulvaney initiated this project on behalf of the RHR. He published it locally through Belgrove Press and it is being sold for \$15 (Orders to mulvaney@netspeed.com.au). The proceeds from the sale of this book after costs will assist RHR with its work.
- We continue to gain new members who attend the monthly activity while the number attending these sessions has not changed. The placing of membership information signs by



Paul Ratcliffe at entrances to the Reserve has proven to be productive and more signs will be placed other entrances.

- As part of the campaign last year to end the plans to build embassies on the undeveloped part of the Federal Golf Club lease, RHR wrote to Simon Corbell, Minister for the Environment and Sustainable Development, seeking the transfer of this 15 hectare area to the Red Hill Nature Reserve. This has been followed up a number of times with the Minister, Minister Shane Rattenbury and a number of government officers, including taking some of these officers on a guided walk of the area in question. Government activity includes discussions being undertaken with the Golf Club and inter-departmental meetings being held but no decision has been made as yet.
- Following the discontinuation of plans to build embassies on this part of the Golf Club lease, the RHR President has had a number of meetings with the President of the Club. These meetings have been cordial and constructive. Topics have included the future of the undeveloped section of the Club lease and the planned apartments/hotel developments near the Clubhouse.
- RHR hosted a meeting of the Parkcare and Landcare Coordinators on 6 August and a guided tour of the area was provided.
- Michael Mulvaney led a wildflower walk at the AGM on 4 November 2012 and will do so again at the 2013 AGM on 1 December 2013.
- An afternoon tea was held at the Red Hill Lookout café on 30 August. Fourteen people attended including Jasmine Foxlee, Parkcare Coordinator. This event was a trial aimed to reach out to more people on the RHR mailing list and as a way of exchanging ideas and information. A number of ideas were generated that are being considered by the RHR Committee and further such meetings will be held in the future.
- The Centennial Trail was launched recently and the separate walking and bike paths through the Red Hill Reserve are the existing paths negotiated by RHR with the ACT government.
- We currently have 41 financial members and 103 members and friends on our group email list.

There was also a question on RHRG's position on the 15 hectares being sought for return to the Reserve from the Federal Golf Club lease. This is subject to an ongoing discussion currently awaiting further advice from the ACT Government.

7. Treasurer's Report

The drop in income is due to no grants being sought or awarded during the year. Expenses are as detailed. The balance at 30 June 2013 is \$2,109.43.

8. 2013-14 Activities

A kangaroo count is planned for March. M Mulvaney noted the last count of about 800 is about the sustainable limit.

Woodland restoration funding is available in 2013-14 for the Callum Brae area which includes Red Hill. At this stage the proposal is for chainsawing Cootamundra wattles, planting above Tamar Street, and importing logs to protect plantings and provide habitat. The total estimated cost is \$30,000 to \$40,000.

The RHRG work will include restoring the Callistemon plantings on the eastern side, near the summit café, clearing verbascum near Davidson's trig and possibly starting weekday sessions.

It is also possible that the monthly work day will change from the first Sunday to the second to enable the Parkcare ranger to attend.

9. Election of office bearers

Norm Pushack was nominated as the returning officer noting all current office bearers were re-nominating, except for Julie Thoms.

R Kingsland requested two additional positions be filled – equipment officer and activities officer.
