**3. Minutes of the 2013 AGM**

The Secretary advised that day-to-day emails are not included in the correspondence report.

**6. President's report**

The President spoke to the report at Attachment A:

- RHRG has had a good year overall.
- Bulk of work was on removing Cootamundra wattles, and verbascum. Also work commenced on clearing the callistemon planting near the restaurant. The last remaining area of really dense woody weeds is around the golf course.
- Weekday activities well attended, and more participants are welcome.
- New positions established: Notices Co-ordinator and Plantings Co-ordinator.
- Work plan being developed.
- Discussions with the Federal Golf Course are ongoing; no specific development planned yet.

- Celebrations of 25 years of Parkcare included a two-day forum. Michael Mulvaney a great success as after dinner speaker. Next forum in 2015.
- 42 members and many more on the 'friends' email.
- Many thanks to the Parkcare Co-ordinator Jasmine Foxlee and the Parkcare Ranger Craig Wainwright for their excellent work.

M Mulvaney noted that the number of developments per annum on the reserve, by Telstra, ACTEW etc, is decreasing.

## 7. Treasurer's Report

The Financial Statement for 2013-14 is on the RHRG website.

## 8. 2013-14 Activities

M Mulvaney noted the work done to remove Cootamundra wattles; and that the new plantings will need watering over summer.

In 2015 RHRG will:

- try to complement contractor work mainly by undertaking work which the contractor doesn't do such as removing small patches of weeds, and weeds of lower priority
- probably not work on Cootamundras for the next six months.
- Consider doing rabbit warren mapping on a scheduled Sunday working session.
- Not do a kangaroo count, although Don Fletcher may seek assistance to do this.
- Thistles – to be considered. It is too late to spray Saffron, Spear and Scotch thistles but they can be cut and chipped.
- Some weeds seem to be in greater or lesser numbers depending on the nature of the season. Need to keep an eye on St John's Wort

## 9. Election of office bearers

Norm Pushack was nominated as the returning officer. Ross Kingsland noted that all current office bearers have nominated but other nominations were definitely welcome.

R Kingsland requested two additional positions be filled – Notices Co-ordinator and Plantings Co-ordinator.

## **ACT Red Hill Regenerators – President’s Annual Report 2013-14**

Red Hill Regenerators (RHR) continues its work with energy on a number of fronts.

### **Highlights**

- We continued removing Cootamundra wattle on the northern slopes of Red Hill (above Mugga Way) as well as woody weeds, thistles and verbasicum in different areas of the reserve such as Davison Trig and behind Garran. We also spent an energetic session removing woody weeds from the first few rows of the Callistemon plantings near Red Hill summit. This grove of Callistemons was planted by Charles Weston and is a heritage site.
- I am please that we continue to gain new members who attend monthly activities. We are attracting a pleasing 10-15 people each month with an additional 5 or so at the weekday activities. Overall, we put in over 400 hours in 13 different activities. And you can see the difference – there are no longer any large blocks of woody weeds and in amongst the large pyrocanthus and cotoneasters, we are now removing smaller plants before they get established. There’s still no shortage of work but the committee is looking at where we go from here. We are likely this year to ask your help in measuring what weeds we have and where they are located so that we can share with you a plan of action. I think that we may be able to convince more people to join us if we can show them such a plan. We definitely want more participants sharing our passion so please help us grow the number of active members.
- We are maintaining a regular dialogue with the Federal Golf Club. The Club is still committed to a commercial development within their current footprint although the location for this changes from time to time. We are not supportive of a development on the boundary with the unused section of their lease as this would require fire control measures in high value woodland. It is pleasing that the ACT government has indicated that this unused section of the golf club lease is recognised for its environmental value and would not be approved for development. The golf club has acknowledged that this is the situation but we are keen to have this section formally made part of the Red Hill reserve to protect it in the longer term.
- The ACT government recently celebrated 25 years of ParkCare and Landcare in the ACT with a forum. It really was a wonderful opportunity to reflect on the growth and development of this movement that works so effectively as a community/government partnership. Michael Mulvaney was a founder of this group, which was amongst the first ParkCare groups and he is still a major driving force for the whole movement. The forum included a field activity on Red Hill on the topic of weeds and this has influenced our future planning. The forum was funded by the Parks and Conservation Service and the Environment and Planning Directorate. The event was so successful, it is hoped that such forums will be held every year or two in the future.
- Michael Mulvaney led a walk around the summit of Red Hill at the AGM on 1 November 2013 and will lead a walk at the 2014 AGM on 7 December 2014 from Rusden Street, Garran.

- An afternoon tea was again held at the Red Hill Lookout café on 13 March and we heard from Craig Wainwright, the ranger supporting ParkCare groups about his significant contribution to this reserve and his other work.
- The work is almost finalised on the Centennial Trail including from the first lookout on the summit road. Down the stairs from the lookout, one now comes to the Tardis, a new feature of the reserve, which has even been the site for a wedding recently. The Centennial Trail path at this point coincides with our signposted Red Hill Trail.
- We currently have 49 financial members and 122 members and friends on our group email list.
